► **ELIGIBILITY:** The South Central Region Teen Ministry grants, scholarships, or matching funds are offered only to Unity individuals, Ministers and ministries, and organizations in the South Central Region. All applicants must meet the eligibility criteria for the Event, and be active in a Unity ministry or organization in good standing with the South Central Region and Unity Worldwide Ministries (Association of Unity Churches).

► **EVENT ATTENDANCE REQUIRED:** Scholarship recipients are credited with funds at time of grant. However, scholarship funds are contingent upon participation in the Event and thus are not paid until after the Event. Recipient must attend the Event in order to qualify for disbursement. In the recipient cancels or is a no-show, the Recipient and Church are responsible for payment of cancelled Scholarship Funds.
